

NOATAK-KOBUK-COLVILLE PRECINCT.

COMMENCING at a point on the shore of Escholtz Bay, situated at the northern limit of the Buckland River watershed; thence easterly along the northern summit of the Buckland River watershed (identical with the boundary line of Fairhaven Precinct) to a point on said summit situated at the extreme northeast end of the said Buckland River watershed; thence easterly and northerly along the southern summit of the Selawik River watershed to a point on the summit of Zane Pass (situated between the headwaters of Selawik River, the headwaters of the Pah River, a tributary to Kobuk River, and the headwaters of Sakli River, a tributary to Koyukuk River); thence easterly and northerly along the summit dividing the watershed of Kobuk River towards the north and west and the watershed of Koyukuk River towards the south and east to a point of intersection with the 154th Meridian; thence north along the 154th Meridian (identical with the boundary line dividing the Second and Third Judicial Divisions of Alaska) across the watershed of Alatna River, a tributary to Koyukuk River, to a point of intersection with the northern summit of the said Alatna River watershed; thence westerly along the northern summit of Alatna River watershed to a point of intersection with the southern summit of Colville River watershed; thence northerly along the western summit of the Colville River watershed to a point on the shore of the Arctic Ocean situated at the western limit of the Colville

River water shed; thence westerly and southerly along the coast of the Arctic Ocean to Cape Kruzenstern situated at the entrance to Kotzebue Sound; thence southeasterly on a straight line to Cape Blossom; thence southerly and easterly along the shore of Kotzebue Sound and Escholtz Bay to place of beginning.

Embracing all of that ground or land draining into Escholtz Bay north of the northern limit of the Buckland River watershed, all of that ground or land draining into Kotzebue Sound between Escholtz Bay and Cape Kruzenstern, all of that ground or land draining into the Arctic Ocean between Cape Kruzenstern and the western limit of the Colville River watershed, and all of that ground or land contained in that part of the Alatna River watershed situated west of the 154th Meridian.

(The Noatak-Kobuk Precinct also includes the territory formerly known as the Colville Precinct, which was consolidated with the Noatak-Kobuk Precinct by order of Court dated April 27, 1904, said Colville Precinct being described as follows:)

BEGINNING at the mouth of the Colville River and following said Colville River to the point where it crosses the one hundred fifty-fourth degree of west longitude for the second time, thence south on said Meridian to the intersection thereof with the sixty-eighth degree of north latitude, thence east along the divide between the waters flowing into the Arctic Ocean and those flowing into the Koyukuk River, to a point on the divide between the Chandler

River and the Sawanukto River at the head of Dietrich River; thence north along the divide between the Sawanukto and the Savaovik Rivers to Anxiety Point on the Arctic Ocean; thence west to the place of beginning.
